# FUNDING FOR HOME AND COMMUNITY BASED SERVICES





COSTS FOR STATE-FUNDED
NURSING HOME BEDS ARE HIGH

More than 9,600
Georgians age 60+ are on waiting lists for HCBS. As wait lists grow service costs cont



grow service costs continue to rise. These services cost far less than living at a nursing home and during the COVID-19 pandemic many who need care have preferred to remain at home.

## INCREASE FUNDS FOR ALTERNATIVE HCBS CARE

\$10 million in the FY2023 DHS budget for state-funded non-Medicaid HCBS. The average cost in FY2021 was \$2,227 per person per year. This is far less than what the state would pay to place individuals in a Medicaid nursing home bed.

## WAITLIST NUMBERS ARE RISING ALONG WITH SERVICE COSTS



COVID-19 has taken a disproportionate toll on older adults, many of whom face new

conditions of daily living. Funding is needed to cover meals, personal home care, caregiver respite, and other HCBS services.

# ADD FUNDS TO THE DHS AFY2022 BUDGET FOR HCBS

Add \$8.1 million to the DHS budget to match \$37.9 million ARP funds. Together these funds would provide thousands of Georgians with much-needed support services from the Older Americans Act.

The need for caregiving increases with age. In 2018, the percentage of older adults age 85 and older who needed help with personal care (21%) was more than twice the percentage for adults ages 74-84 (8%) and five times the percentage for adults ages 65-74 (4%).
